Maintenance Worker Greg Schultz reported Sewer Pond transfers are done, Lift Station has been serviced for the year, Red Rock Laying, Park Shelter re-roof is complete, Lawnmower repairs are done, Water at the Baseball Park has been turned on for the season with the first game there this Saturday, the tailgate on the Chevy 1 ton city truck needs repairs, began taking down sheetrock in the City Shop and now awaiting bids, garbage cans and tables have been put out under the shelter this week, there has been quite a bit of vandalism at the park already this year, Flag pole by the lift station bends too much and would recommend having Country Side Flag Pole come out to cement it in the ground and repair the raising/lowering mechanism on the flag pole at the City Office.

- The Lions Club has a budget of \$980.00 for trees –A list of tree types is needed before the upcoming Kahnke Brothers tree auction.
