- Councilmember Lund moved to approve Resolution Number 2015-06 approving the plans and specifications and ordering advertisement for bids for the 2015 Street Improvement Project, seconded by Councilmember Gregonis and motion unanimously carried. All Council members were present.
- Bids for this project will be received until June 2, 2015 until 10:00 a.m., at which time they will be opened in the council chambers by City Clerk Gruenhagen and the City Engineer.
- The bids will be tabulated and the findings will be presented to the City Council on June 16, 2015.

  - Clarke Mosquito Control will be spraying for mosquitoes this year on Tuesdays. If the City would want to have them spray on Thursday, as in the past, they now charge an extra premium for that day.
