 - WAC/SAC charges
 - Wm. Mueller & Sons is looking to purchase the UFC properties and sell the landlocked parcel, Property I.D. #45.0283000, to the city in exchange for WAC/SAC charges. UFC is checking with the Railroad Commission for access to said landlocked parcel. Water and sewer hook-ups to be completed by the end of June, projected to close on the sale of the property at the end of August.
